CCH100 CABLE CATCHER USER'S GUIDE





PRECAUTIONS / SAFETY WARNINGS 1

Please read this manual carefully before using your **CCH100** Cable Catcher. Keep this manual handy for future reference. These safety instructions are to ensure the long life of your **CCH100** Cable Catcher. Please read them carefully and heed all warnings.

1.1. GENERAL

 There are no user serviceable parts inside.
 Only qualified ALTINEX service personnel must do all service on the CCH100 Cable Catcher.

1.2. INSTALLATION

- For best results, place the CCH100 Cable Catcher on a flat, leveled surface in a dry area away from dust and moisture.
- Do not place the CCH100 Cable Catcher in direct sunlight, near heaters or heat radiating appliances, or near any liquid.
- Exposure to direct sunlight, smoke, or steam can harm the **CCH100** Cable Catcher.

1.3 CLEANING

 Clean surfaces with a dry cloth. Never use strong detergents or solvents, such as alcohol or thinner. Do not use a wet cloth or water to clean the unit.

1.4 FCC / CE NOTICE

- This device complies with part 15 of the FCC Rules. Operation is subject to the following two conditions: (1) This device may not cause harmful interference, and (2) this device must accept any interference received, including interference that may cause undesired operation.

Designed to make computer and A/V equipment connectors more accessible, the **CCH100** Cable Catcher™ allows easy access to cable ends by holding them at the edge of a table or desk. The adjustable rack accommodates various sizes of cables. The screw-tight clamp accommodates a table or desk thickness of up to 1.5 inches (4 cm).

The **CCH100** Cable Catcher allows your most commonly-used cable ends to be easily accessible, and eliminates the need to crawl behind desks or under tables to reach less-than-convenient data and A/V connectors. By running cables up to the desktop and through the Cable Catcher, each signal is conveniently within reach, ready to be accessed and re-routed as your needs for it change. The **CCH100** Cable Catcher is offered in a standard black anodized finish.




INSTALLING YOUR CCH100

- **Step 1**. Attach the unit to the table using the mounting bracket.
- **Step 2**. Place the nylon level underneath the table. Insert the custom screw through the mounting bracket to the nylon level (see diagram 2).
- **Step 3**. Secure the unit to the table using the custom knob.
- **Step 4**. Place cables inside **CCH100** Cable Catcher. The aluminum wire will hold cables in place.

5.1 LIMITED WARRANTY

ALTINEX warrants that its products and cables are free from defects in materials under normal use and service. This warranty is limited to repairing at company's factory any part or parts of the product, which upon company's examination shall disclose to be, thus defective. Products considered defective should be returned to company with transportation charges pre-paid within 2 years (90 days for cables) from date of shipment to the purchaser. The warranty is expressly instead of all other warranties expressed or implied. ALTINEX neither assumes nor authorizes any other person to assume for it any other liability in connection with the sale of the products. This warranty shall not apply to any product that shall have been repaired or altered outside of company's factory in any way so as, in its judgment, to affect its stability or reliability, or that has been subject to misuse, negligence, or accident.

5.2 RETURN POLICY

It is very important to ALTINEX that you receive the products that you have ordered and that this product meets your expectations. In the unlikely event, that an ALTINEX product needs to be returned please follow the policy below:

ALTINEX will accept product returns for a period of 30 days from authorized ALTINEX dealers.

Products must be returned in an unopened package.

If a product has been opened, the restocking fees will apply. For the restocking fee amount, please contact an ALTINEX Sales Representative.

If the product is in your possession for more than 30 days, the restocking fees will apply.

ALTINEX will not accept any returns on cables or custom products.

If your product is in warranty and needs service, contact the ALTINEX Sales Department for an RMA (Return Material Authorization). Products returned without an RMA number may experience a delay in service.

If your product is out of warranty and needs service, contact the ALTINEX Sales Department for an RMA (Return Material Authorization). Products returned without an RMA number may experience a delay in service. The service charges will be quoted to you before the actual repairs are done.
