DESCRIPTION

The 100BK tripod stand is designed to support speaker systems weighing up to 85 lb. The speaker's stand-mounting inserts must have an inside diameter of 1% inches.

SETTING UP

On removal from the box, first tighten the collar lever and loosen the leg fitting lever. Now turn the tripod upside down and pivot each leg outward enough to start sliding the leg fitting. Return the tripod to upright position and adjust the leg spread to the desired diameter by sliding the leg fitting. Be sure to tighten the lever on the leg fitting snugly after adjustment.

NOTE

Do not over tighten the levers, as this will result in undue stress on the fitting. Just tighten enough to hold its position firmly.


Raise the speaker up and then lower it onto the tripod upper tube. The top of the tripod can be lowered within easier reach by adjusting the leg spread to a smaller diameter. Leg spread can be readjusted after the equipment is mounted. Loosen the collar lever and raise the upper tube to the desired height setting; then retighten the lever snugly. There is a white arrow marking the last 6 inches. Do not extend it higher than this point.

BREAKDOWN

Exercise extreme caution when loosening either lever while the tripod has a load on it. Lower the upper tube slowly until it bottoms out. Tighten the collar lever before attempting to lift the equipment off. Then loosen the leg fitting lever and return the legs to their folded positions.

CARE

Treat the stand with the care that any fine instrument deserves. Dents in the lower or upper tube will hamper the telescoping action. A damp cloth or non-abrasive cleaner can be used to clean the stand.
