Introduction

The XAP™ IR Remote Control system is designed to allow easy operation of XAP products from your desk or conference table, rather than from the front panel or G-Ware™ software of your ClearOne audio conferencing products or an expensive external controller.

It consists of two components: the handheld infrared transmitter (remote control) and the base station infrared receiver. The remote control is used to operate or customize certain features of the XAP system, such as connect, disconnect, dial a telephone number, redial, activate speed dial, hook flash, adjust volume, and mute the microphones.

The XAP IR Remote functions with various XAP stand-alone or combined systems. The remote's default programming can be easily customized to fit your needs by using G-Ware, the XAP system's configuration software. In the event of a power outage, the new programming will be stored in the receiver's memory and will not be lost or altered. The remote also provides positive feedback for the Mute LED and In Use LED by actively monitoring the response of the controlled unit(s) and indicating the correct status of each function.




Figure 1. XAP IR Remote Control System

Installation

XAP IR Remote Receiver

Installation is simple. Plug the XAP IR Remote Receiver into the RS-485 Remote Panel A or Remote Panel B connector located on the back of the ClearOne unit.




Figure 2. XAP IR Remote Control Receiver

Alternatively, you can connect the receiver to a network of ClearOne Control Panels which are connected to one of the RS-485 ports on the rear of the ClearOne unit. In this case, connect the IR receiver as the last device in the daisy chain. Up to five control panels and one IR receiver can be connected to an RS-485 port.

Refer to the table below for maximum cable runs. The distances indicated are for category five twisted-pair cable.

Figure 3. Category five cable run distances




Figure 4. Typical XAP IR Remote Receiver installation

DIP switch configuration

Located on the rear of the receiver are five DIP switches. These switches are default programmed at the factory to allow the receiver to operate without adjustment when it is connected to one of the RS-485 Remote Panel ports on the rear of the ClearOne conferencing unit.

If you are connecting the IR Remote receiver to a network of ClearOne Control Panels (which are connected to one of the Remote Panel ports), **ensure that DIP switch 5 is set to on**; this serves as the termination of the daisy chain, since the IR Remote is always connected as the last device in the chain. Set DIP switches 1–4 according to the table in Figure 5.

As an example, if you have three Control Panels connected to Remote Panel A and you want to connect an IR Remote receiver to the daisy chain, the receiver would be number 3 (the Control Panels being numbers 0, 1, and 2). Therefore, the DIP switch settings for the IR receiver would be 1=Off, 2=Off, 3=On, 4=On, and 5=On.

Always connect the IR Remote receiver to the last Control Panel when connecting to a daisy chain of Control Panels. Only the last device in a daisy chain should have the last DIP switch set to On (to terminate the chain).

Front Panel LEDs

Configuration

There are three LEDs on the front of the XAP IR Remote—Mute, In Use, and Ready.

- **Mute.** The Mute LED flashes red when microphones are muted (default). You can program this LED to illuminate to another command in the Remote Builder window of G-Ware. See Configuration (below) for more information.
- In Use. The In Use LED glows red whenever a phone participant is on the line. The programming of this LED cannot be changed.
- Ready. The Ready LED glows red when the receiver is connected to a XAP or PSR1212 product, indicating the system is ready for a valid command. The programming of this LED cannot be changed.

When a button is pressed, the Ready LED flashes, indicating a command has been received.

Configuration

Programming Functions

The XAP IR Remote Control is programmed by default to operate a single XAP 400 with an amplifier and speaker connected to Output 8; however, it is easy to customize should you require different specifications. If you want to use the factory defaults, proceed to Operation on page 12. Below are instructions for setting up the remote control in ClearOne G-Ware software, the user interface for XAP products.

XAP IR Remote system defaults

The XAP IR Remote is programmed by default to operate the XAP 400/TH2 Telephone Interface as follows: The On, Off, 0-9, *, #, Flash, Redial, Speed Dial, and Conference Call keys activate any XAP 400/TH2 on the expansion bus network regardless of its type and device ID. This is because of the default ** programming, which allows the selection of any device on the network.



Buttons programmable in G-Ware are illustrated in Figure 12 (page 12).

Configuring G-Ware Remote Builder

 Open the Remote Builder window in G-Ware by clicking the Remote Builder Flow Screen button or Remote Builder toolbar button.

- Select a remote ID number from the Select Remote ID list and IR Remote from the Select Remote Type drop-down lists. Note that the Select Remote ID must correspond to the ID you established with the DIP switches (see page 4).
- 3. Click **Change Name** to create a more descriptive name for the remote which is displayed in addition to the remote ID number (limit 20 characters).
- 4. In the Telephone Interface section, select the **Device Type** and **ID** of the unit (XAP 400 or XAP TH2) that you want the XAP IR remote to use when making and receiving calls. The default settings are ** which will select any telco device found on the network. If you have multiple telco devices in your network, you must specify which unit will be used to make and receive calls so that multiple telco devices won't be activated.
- 5. Select the button or LED you want to program from the **Select Button/LED** list. You can also select the button or LED by clicking directly on the picture of the remote. (Selectable buttons are colored white.)

- 6. Click the **Active Command** or **Inactive Command** button to set the command for operation when the button is active or inactive.
- Select the **Device Type**, **ID**, and **Command** from their respective lists. When you select a command, a description of it appears in the Command Description box.

- 8. Select the command parameters from the argument lists. The parameters that are available depend on the command selected. When you select an argument, a description of it appears in the Argument Description box.
- Click the Apply button to apply the command to the selected Active or Inactive Command button. Or, click Clear to reset the command to default settings.

Repeat steps 5-9 for each additional button you want to configure.

10. Click Close to exit the Remote Builder.

Speed dial

Configuration

The XAP IR Remote Control system supports 10 speed dial numbers. Each number can be 40 digits long and can have a 20-character name. These numbers and labels are stored in non-volatile memory of the XAP conferencing unit and each number can be called by a single command. Any valid touch-tone digit and the pause character (comma) can be stored. All speed dial numbers are empty except for Speed Dial 9, which is programmed with ClearOne's technical support number, and Speed Dial 10, which is programmed with the conference calling services number. See pages 14-15 for information about using speed dial numbers.

To configure speed dial numbers

- Click the **Dial** button in the G-Ware Flow Screen.
 The Dial window opens.
- 2. Click **Edit** in the Speed Dial section. This opens the Speed Dial Edit window.
- 3. Enter the name and number to dial in the appropriate fields.

4. Click **Save** to save changes and exit.

Programming Example A

This example illustrates how to configure the remote control to adjust the speaker output (output 9) of a XAP 400.

To program volume control of output 9

 Open the Remote Builder window in G-Ware by clicking the Remote Builder Flow Screen button or Remote Builder toolbar button.




Figure 10. Remote Builder screen with Volume Up button configuration

- Select the remote ID number of the remote you want to program from the Select Remote ID list and IR Remote from the Select Remote Type dropdown lists.
- Select the Volume Up button from the Select Button/LED list. You can also select the button by clicking directly on the Volume Up button in the remote control depiction.
- 4. Click the **Active Command** button to set the command for operation when the button is active.

Select RAMP from the **Command** dropdown list.

- 8. Select channel 9 from the Channel list.
- 9. Configure the Group, Rate, and Target lists. The Group list indicates the location of the XAP 400 in a network. The Rate list indicates the number of dB per second that the volume ramps up. The Target list indicates the target dB increase, which is 6dB (a decibel level selected for purposes of this example).
- 10. Click the Apply button to apply the command to the selected **Active Command** button.

To configure the Volume Down button, follow the same procedure, except in Step 3, select the Volume Down button, and in Step 9, select -6 (dB) in the Target list. You would select -6 because you want the Volume Down button to decrease the volume to -6dB. This means the Volume Up/Volume Down range is 12dB.

Click Close to exit the Remote Builder.



Programming Example B

This example illustrates how to configure the remote control to mute all mics on multiple connected units (in this case, a XAP 400 with a device ID of 0 and a XAP 800). In this example, the XAP IR Remote receiver is connected to the XAP 400.

To mute multiple units

 Create two macros (one to mute, one to unmute) to mute all microphone inputs on all connected units. This is accomplished using the Macro Editor in G-Ware. See the respective XAP 400 or XAP 800 manual for details about using the Macro Editor.

The mute macro has the following command lines:

For the XAP 400: 7 * Mute * M 1, where 7=Type (XAP 400), *=DID (Device ID), Mute=command, *=Channel, M=(Mic) Group, and 1=Mute Mode (on).

Configuration

The unmute macro has the following command lines:

For the XAP 400: 7 * Mute * M 0 For the XAP 800: 5 * Mute * M 0

- After you have created and saved the macros, open the Remote Builder screen in G-Ware and select the appropriate remote ID number from the Select Remote ID drop-down list and IR Remote from the Select Remote Type drop-down list.
- Select the Mute On button from the Select Button/LED list. You can also select the button by clicking the Mute On button in the remote control depiction.
- 4. Click the **Active Command** button to set the command for operation when the button is active.
- 5. Select 7 (for the XAP 400) for the device Type from the Type drop-down list.
- 6. Select 0 for the device ID from the **DID** list.
- 7. Select MACRO from the **Command** drop-down list.
- 8. Select the macro number of the "mute on" macro you created from the **Macro** list. The Macro Label field will reflect the name you have given the macro.
- 9. Click the **Apply** button to apply the command to the selected Active Command button.

To configure the Mute Off button, follow the same procedure, except in Step 3, select the **Mute Off** button, and in Step 8, select the macro number of the "mute off" macro you created.

When you are finished, click **Close** to exit the Remote Builder.

Operation

Getting Started

Once your remote is connected to your XAP system, you have configured it, and the Ready LED is lit, you can start using your remote control.

Operation is easy and straightforward. Please consult the diagram on the following page to learn how each button on your remote works.




Figure 12. XAP IR Remote Control button descriptions

Remote Control Buttons


While within 25–40 feet of the receiver, point the remote control toward the receiver and press the buttons to operate.

To place a call

1. Press Telephone On (green) button. The In Use LED illuminates.



- 2. Wait to hear dial tone.
- Dial telephone number using dial pad. Or, press Speed Dial and the location of the speed dial number.



To end a call

Press Telephone Off (red) button. The In Use LED extinguishes.



To adjust the volume in the room

· Press the **Volume Up** button to raise the volume.



- · Press the **Volume Down** button to lower the volume.



To mute microphones

· Press the **Mute On** button.



Mute LED will flash on receiver when the Mute function is active. This function mutes all microphones in the room.

To turn off mute

· Press the **Mute Off** button.



Mute LED on receiver will turn off when mute function is off.

To access features from a PBX

Press the Flash button.

Battery life:

Please consult your PBX owner's manual for specific requirements of your individual phone system. G-Ware can be used to adjust the hook flash duration to match your PBX. This setting is located in the Telco Config window in G-Ware.

To redial the last telephone number dialed

Press the Redial button.



To dial a number stored in speed dial

 Press the Speed Dial button. Select location (0-9) of the speed dial number with the appropriate numeral button. Speed dial memories 1-9 correspond to buttons 1-9; speed dial 10 uses button 0.





In order for the Speed Dial function to work, a telephone number must be programmed into the XAP product. Please see Speed Dial on page 7.

To change the button programming of your XAP IR Remote

The **Program** button is not factory-configured. However, it can be programmed in G-Ware to execute a command.



To dial a conference call center

The Conference Call button is defaulted to dial ClearOne's Conference Call services (stored in Speed Dial 10, which uses the 0 button).
